Through the Weatherization Program, energy conservation measures are addressed to help eligible families reduce fuel consumption for heating and cooling. This program uses the NEAT Audit to determine what measures need to be done to the home, i.e., insulation, weather stripping, new doors / windows, replacing inefficient heating / cooling appliances.

The Weatherization Program is NOT a repair/rehab program. Only measures improving the energy efficiency of the home can be performed.
